Dear Pool Permit Holder,

We want to take this opportunity to inform you of the plan for this upcoming pool season:

Access to your pool and pump/filter room by Gwinnett County Environmental Health personnel, for the purpose of unannounced inspections during the upcoming year, is required by the regulations to prevent pool permit suspension. For pools that do not have on-site staff, please send an e-mail to [gwinnetthealthpoolinspections@gmail.com](mailto:gwinnetthealthpoolinspections@gmail.com). You will receive an automated response with a link to an online form to submit required information including; facility name, permit number, gate code or lock box combination, and pump/filter room code or lock box combination. This form must be completely filled out with all required information. Completing the form with "same as last year" or any other similar response will not be accepted. Please be advised a facility with multiple pools will need a form completed for each pool not within the same enclosure. This requirement also applies to spas.

1. Once a completed on-line form is provided, and fees paid, your pool may be opened. New construction pools and pools that have undergone a change of ownership will require an inspection before operating.
2. In order to reduce waterborne illnesses and accidents, multiple educational tools are available on our website at [www.gnrhealth.com](http://www.gnrhealth.com) for your review.
3. Like last year, we will be assessing pools for compliance in regards to adequately designed covers for main drains and skimmer equalizer lines to reduce the risk of suction entrapments.
4. Please be advised, all violations, critical and non-critical, not corrected with Gwinnett Environmental Health staff onsite will require a follow-up inspection that will cost an additional fee.
5. A two-day Certified Pool Operator (CPO) class will be offered on **March 27<sup>th</sup>/28<sup>th</sup>** and **April 10<sup>th</sup>/11<sup>th</sup>**. To register, please visit the Gwinnett Environmental Health office located at 455 Grayson Highway, Suite 600, Lawrenceville, Georgia 30046.
